Every person engaged in the practice of a water distribution operator must hold a valid certificate of registration issued by the Environmental Certification Board. Application for certification must be in the Board's office within ninety (90) days of beginning employment as a water distribution operator.

Employers, Supervisors and Licensees are responsible for notifying the board, within fifteen days, whenever employment in a position requiring certification is begun or terminated.

To be eligible for certification as a water distribution operator, one must meet the experience requirements (relative to each certification level) established by the Board, and pass the certification examination for the "D", the "C", the "B", and the "A" level(s) (depending on the highest level one wishes to reach).
