Every person engaged in the practice of physical/chemical wastewater operations must hold a valid certificate of registration issued by the Environmental Certification Board. Application for certification must be in the Board's office within ninety (90) days of beginning employment as a biological wastewater operator.

Employers, Supervisors and Licensees are responsible for notifying the board, within fifteen days, whenever employment in a position requiring certification is begun or terminated.

To be eligible for certification as a physical/chemical wastewater operator, one must meet the experience requirements (relative to each certification level) established by the Board, and pass the certification examination for the "D", the "C", the "B", and the "A" level(s) (depending on the highest level one wishes to reach).

ATTESTATION , hereby make application for certification as a physical/chemical wastewater operator in the State of South Carolina, in accordance with Section 40-23-305 of the South Carolina Code of Laws, 1976. In doing so, I affirm that I will perform my duties as an operator as required by law and will obey all rules and regulations promulgated by the South Carolina Environmental Certification Board. Further, I certify that all information given on this application is correct to the best of my knowledge. Incorrect statements may be cause for return, disapproval, suspension or revocation of the application.
