PROFESSIONAL GEOLOGIST REGISTRATION INSTRUCTIONS

Requirements

- All applicants applying for a Professional Geologist registration must have graduated from an
 accredited geologic curriculum of four or more years approved by the board; and provide proof
 to the board of five years of work experience (four years with a master's degree in geology).
 Applicants must pass both portions of the National Association of State Boards of Geology
 (ASBOG) examination.
- Submit Employment Verification(s) showing a minimum of 5 years work experience in the field of geology after graduation from an approved college. Forms should be sent to present or previous employers for completion and forwarded directly to the Board's office.
- Three (3) professional references submitted by geologists or engineers who have known the applicant a minimum of one year and can attest to applicant's character and reputation.
- Verification of Registration/Licensure forms must be forwarded directly to the Board's office from all states where they are registered as a Geologist.
- Transcripts must be in an original sealed envelope directly from the school or college.

• Check or money order only made payable to the SC Board of Registration for Geologists. ALL FEES ARE NON-REFUNDABLE. NO CASH IS ACCEPTED. A returned check fee of up to \$30, or an amount specified by lay may be assessed on all returned funds.

FEE: \$200 – Two year registration

\$150 – Prorated fee for applications submitted after April 1st of even years (2016, 2018, etc.)

The South Carolina Freedom of Information Act ensures that the public has a right to access appropriate records and information possessed by a government agency. Therefore, some personal information on the application may be subject to public scrutiny or release. The Department collects and disseminates personal information in compliance with The South Carolina Freedom of Information Act, the South Carolina Family Privacy Protection Act, and other applicable privacy laws and regulations. Additionally, the Department shares certain information on the application with other governmental agencies for various governmental purposes, including research and statistical services.
