2023-2024 CEMETERY RENEWAL APPLICATION

Renewal Instructions/Requirements:

- Renewal fee in the form of a check or money order (no cash) made payable to LLR-Perpetual Care Cemetery Board. (All fees are non-refundable. A returned check fee of up to \$30, or an amount specified by law, may be assessed on all returned funds.)
 - o Perpetual Care Cemetery license with 10 acres or less postmarked on or before 1/31/2024, fee is \$400.
 - Perpetual Care Cemetery license with more than 10 acres postmarked on or before 1/31/2024, fee is \$850.
- Failure to renew by December 31, 2023, renders the license invalid. The license may be reinstated by January 31, 2024. Delinquent renewal requests not postmarked on or before January 31, 2024, require a new application and application fee to be submitted under current guidelines.
