LLR Recognizes Safe Workplaces

Twenty South Carolina companies are being recognized for their outstanding safety records through the South Carolina Department of Labor, Licensing and Regulation's 2014 Safety Achievement Awards program. The program recognizes a firm's efforts to reduce recordable occupational injuries and illnesses of their workers during the past year.

LLR's 2014 Safety Awards program awarded companies that reduced and/or eliminated OSHA recordable injuries and illnesses between 2013 and 2014. The awards also recognized companies that worked at least 1 million hours without a lost-time accident.

LLR's Safety Awards program is open to any employer that has an average of 100 or more employees. The Awards are presented in four categories:

- No recordable injuries or illnesses.
- A reduction of at least 40 percent in an employer's incident rate between 2013 and 2014.
- A difference of at least 75 percent in an employer's incidence rate and the South Carolina average rate for that industry.
- Worked one million work hours without a lost-time injury or illness.
