LLR ANNOUNCES 2021 SAFETY AWARD RECIPIENTS

As we conclude the celebration of National Safety Month, the South Carolina Department of Labor, Licensing and Regulation announces the recipients of the 2021 Safety Achievement Awards. The Safety Awards program is the Agency's way of rewarding employers, both large and small, for the success of their safety and health programs.

The 2021 Safety Award Recipients are in the following three categories:

Palmetto Shining Star – These employers met at least one of the following criteria for the *private sector*: (1) no recordable injuries or illnesses during calendar year 2020; (2) a reduction of at least 40% in the employer's incidence rate between 2019 and 2020; (3) a difference of at least 75% in the employer's 2020 incidence rate and the 2019 South Carolina average rate for that industry; or (4) worked one million or more safe work hours without a lost-time injury or illness. For the *public sector*, the employers met one of the following criteria: (1) no recordable injuries or illnesses during calendar year 2020; (2) a reduction of at least 20 percent in an employer's incidence rate between 2019 and 2020; or a difference of at least 50% in the employer's 2020 incidence rate and the 2019 South Carolina average rate for that industry.
